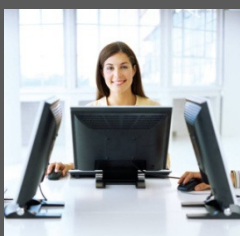

- **PIV System Implementation** - We designed, integrated, implemented, and maintained a solution compliant with VA lifecycle identity and access management requirements. The solution supports a strategy that enables VA to reduce capital investment needs over time, reduce help desk demands, and migrate the infrastructure to web services and solutions. The VA PIV solution is expected to support more than 500,000 users and can scale to manage the identities and access privileges of more than 26 million Veterans. Our significant achievements include:

 - Developed transition plans and completed cost benefit analysis for PKI consolidation, identity management, and data management
